

**Registration Information for the Quilt Show 2009**  
**April 18 and 19, 2009**

1. **Information about judged quilts:** Any quilt, except one that is framed, is eligible for judging, including tied quilts this year. In order to encourage as many quilters as possible to participate in the judging, and in order to give fair judging time to each entry, the number of quilts judged per person MAY be limited, depending on the number of entries received. Please enter as many quilts as you would like for judging. Number those entries you would like judged according to the priority in which you would like them accepted for judging. Submit the judging fee for all items you want judged. If the number of entries dictates that we have to limit the maximum number of entries per person, then the balance of the judging fee will be refunded.
2. **Definitions:** A **quilt** consists of 3 layers-a top, middle layer, and back-that are joined together. A **judged wearable art entry** should include in design, construction or embellishment one or more quilt techniques such as piecing, applique, quilting or other in some part of the garment. Batting or a middle layer is not required. Any garment can be entered in the non-judged section, whether or not it fits the above description. A **miniature quilt** is defined as one less than 24" x 24" and is a scaled down version of a full-size project. **Quilt Category:** The entry form asks you to define your quilt as traditional or non-traditional. This is entirely your choice as to which category you feel your quilt belongs. It will not be changed by the judging committee.
3. You must submit a separate form for each item entered in the show together with a photo to help the display committee plan the show. All entries must be postmarked by **February 21, 2009**. There will be no exceptions due to arranging for insurance and preparing the catalog. If you are still working on your quilt and are reasonably confident about completing it by the date of the show, please submit your entry before the deadline.
4. There is no limit to the the number of entries per person. This is not a juried show-all entries will be hung in the show unless there are space constraints. Only quilts made by guild members may be entered into the show, except for Youth and Antique quilts. Any quilt made by a guild member may be entered into the show unless it was entered in our last show in 2007.
5. There is a \$2.00 entry fee for each non-judged item and a \$5.00 entry fee for each judged item.
6. The judging committee will organize the judged quilts into categories based on their size and technique. Their decision is final and cannot be changed by the owner or by the judges.
7. Q.U.I.L.T. Inc will provide security and insurance from the time your quilt is in our possession until the quilt is signed out after the show. Insurance for shipping or while being transported by a friend is not included. The maximum we can insure an item for is \$1000. If a registration form has an amount over \$1000, we will ask that you provide an appraisal form or sales record. The amount paid for a loss without an appraisal will be determined by the insurance company, based on the recent sales record of a quilt of like kind and quality. All exhibitors should have high quality overall and detail photos of their quilt in case of loss. Since our cost for this insurance depends on the total value of the insured items, we ask that you carefully fill in an amount for the insurance. While the guild will protect your quilt as well as possible, any insurance claim is your responsibility to validate with the company.
8. Q.U.I.L.T. Inc cannot be responsible for the glass or frame on an item submitted for display. They may be entered at the exhibitor's risk. Framed items are not eligible for judging.
9. All quilts larger than 24" x 24" should have a 6" sleeve sewn onto the back.
10. If a quilt is for sale, a 10% commission will be retained by Q.U.I.L.T. Inc. Include sales tax in your price.
11. Q.U.I.L.T. Inc reserves the right to photograph the quilts for publicity, record keeping, and for fundraising.
