### MEMBERSHIP, DUES, AND GUESTS

Membership is open to anyone who is interested in quilting. Payment of the annual dues of \$30 entitles a member to a Membership Card, voting privileges, a Newsletter subscription, use of the Q.U.I.L.L.T., Inc. library, access to workshops, and special privileges that may arise. Dues are used for renting the meeting space, having guest speakers, and maintaining the Q.U.I.L.L.T., Inc. library.

Numbered membership cards will be issued when dues are paid. Cards are good for the program year, which runs from September through June. Dues paid by new members in April or later are applied through the following guild year. A membership list will be distributed to all members each fall. Guests: There will be a donation for visitors at meetings with a speaker in an amount determined by the Board. Some guild meetings featuring a prominent speaker may have a higher donation or may be closed to non-members.

## MONTHLY GUILD MEETINGS (Programs)

Guild meetings of Q.U.I.L.T., Inc. are held at the Delmar Reformed Church at 386 Delaware Avenue in Delmar on the second Friday of the month unless otherwise stated. Sign-in begins by 9:15 a.m., and guild meetings start promptly at 9:45 a.m. with a business meeting prior to the program. Please come early to visit the library and mini-mart, and the service project, information, and fundraising tables. Guild meetings run from 9:45 a.m. until about 12:00 p.m. Coffee, tea, and baked goods are available courtesy of the Hospitality Committee.

In general there will be a theme to each guild meeting. Some meetings feature a speaker and/or trunk show. At other meetings, we may have mini-demonstrations or an auction; a display of quilts made for a guild challenge, followed by viewer's choice voting; or time set aside to work on service projects (usually combined with our guild birthday celebration). The morning program generally includes Show-and-Share; the afternoon may include a workshop, work on service projects, or a special session, such as Quilting 101, where members share their quilting knowledge. The afternoon is a good time to bring a quilt for basting or any project that you may want help with. Bring your lunch and chat with friends.

**Q.U.I.L.T., Inc. Snow Policy:** If Bethlehem schools are closed or delayed 2 hours due to weather, there will be NO GUILD MEETING; if schools are delayed for 1 hour, the meeting will be held.

### NAME TAGS

Name tags should be worn at each guild meeting. Create a name tag from your own design or use a name tag pattern from the pattern file in the library. To encourage everyone to wear a name tag, there will be a drawing at guild meetings. The member whose name/number is drawn must be present at the time of the drawing and wearing a name tag to receive the quilt-related prize!

### FUNDRAISING

Monthly meetings of Q.U.I.L.T., Inc. include an opportunity to participate in a raffle or other fundraising activity for exciting gifts, including baskets of fabric, gift certificates, quilts, and quilt supplies. Proceeds support guild activities, including speakers.

### INFORMATION TABLE

Our information table contains information on quilt shows and classes, correspondence from other groups, and other flyers of interest to quilters. Feel free to use this space for quilt-related information that you want to disburse to our guild.

### LIBRARY

Our library is a treasure for members who want to learn about color, technique, and new ways of seeing possibilities. Members may borrow books, magazines, DVDs, stencils, templates, and rulers. The library is open every month except December, March, and June.

**Borrowing:** Borrowers may take up to 5 items at once; write your name and date borrowed on the library card in the item and place the card in the designated holder. Items are due at the next month's meeting (or the next month the library is open). Six items may be borrowed at the May meeting for the summer (due at the September meeting). The library is not open at the June meeting, but materials may be returned. Return books in the designated baskets.

Pattern file: Copies **are not** to be removed from the binder. Copies may be ordered from the librarian at a cost of \$1.00 per copy and will be delivered at the next scheduled meeting.

**Renewals:** Items may be renewed if no one else has requested them. Borrowers may renew by re-signing the borrow card in person, asking another member to renew if they will not be attending the meeting, or contacting a Library Committee member to renew.

**Overdue and Lost Items:** Overdue items will carry a charge of \$1.00 per month late, payable upon return of the item. Lost items will carry the following fees: books \$20; DVDs \$15; rulers \$10; magazines \$5; stencils and templates \$10. If the lost-and-paid-for item emerges at a later date, the item may be returned to the library and the money refunded, assuming the item is in good condition.

Library Committee members will do their best to remind borrowers by email about overdue items, in time for the next guild meeting that the library is open. Members who do not return materials, do not declare them lost and pay the fee, and/or do not respond to requests for return, may lose their library privileges.

### **NEWSLETTER**

Q.U.I.L.T., Inc. publishes a newsletter, generally in November, March, and June, that includes notices about upcoming guild meetings, workshops, programs, policy changes, local quilt shows, and miscellaneous quilt-related information. To contribute to the newsletter, mail or e-mail items to the Newsletter Editor. Newsletters will be e-mailed to members unless a member specifically requests a paper copy because of problems accessing the newsletter by computer. Paper copies will be labeled with the member's name and will be available for pick-up at guild meetings. Newsletters will not be mailed. The newsletter can also be found on our website <http://www.quiltinc.org>.

### **QUILT SHOW**

Q.U.I.L.T., Inc. presented its first show in 1988. The show is held every other year in April. Members display quilts, clothing, and other related items. The show is a large undertaking and requires much planning and MANY volunteers.

### **QUILTERS' MINI-MART**

The Quilters' Mini-Mart is one interesting way we have of making money, as well as recycling quilt-related items that members no longer want. Items not sold will be stored as space permits and offered again at the next meeting. Orvus, a soap used by conservators and recommended for cleaning quilts, is available at the Mini-Mart in 3 oz containers for our members at a nominal fee.

### **SERVICE PROJECTS**

Q.U.I.L.T., Inc. is committed to community service and has many ongoing service projects. We ask that each member contribute at least 3 hours of time to these important and worthwhile projects as part of membership. We make many quilts to donate to various local organizations. Some will be distributed to those in need, and others will be used as raffle quilts. At least one guild meeting per year is devoted to work on service projects; work may also be done after some guild meetings or at the homes of members. During service project work days, members may contribute by pinning quilts, cutting fabric, or sewing quilts together. These work days are a great way to meet other members, have fun, and chat. Some members take quilts home to machine quilt or apply bindings, and some members make quilts or quilt tops at home and bring them to guild meetings. Requests from groups seeking quilts from Q.U.I.L.T., Inc. may be submitted to the Service Committee.

For our placemat project, we make placemats throughout the year and in the fall donate them to organizations that provide meals to shut-ins, such as Meals on Wheels, community organizations, and church-based groups. We have a placemat competition for those who wish to participate, with prizes for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place and most placemats made.

## SHOW-AND-SHARE

We encourage all members and guests, whether beginner, intermediate, or advanced quilters, to share their work with the group. Show-and-Share is one of the highlights of our guild meetings.

## WEBSITE

The Q.U.I.L.T., Inc. website is <http://www.quiltinc.org> and includes much information in the public section on guild activities including programs and workshops, quilt show, guild contacts, challenges, special events, library book list, and newsletters. If you join the website, you will be able to access additional content.

## WORKSHOPS

Q.U.I.L.T., Inc. schedules several workshops per year on a variety of quilting techniques. Attending workshops is a good way to learn new techniques, get to know the teachers in a small group, and make new friends. Workshops are not supported by Q.U.I.L.T., Inc. membership dues; attendees pay a fee to cover the cost of the workshop. Workshops have limited registration, which is usually done at guild meetings or by mail.

Members of Q.U.I.L.T., Inc. will be given priority for workshop registration and are encouraged to register early since some workshops fill quickly. Workshops will be publicized in the newsletter, on the website, and at guild meetings. Non-members may register for workshops for an additional fee.

**Registration procedure:** Workshop descriptions and registration forms are printed in the newsletter and are posted on the website. To register, complete the registration form and bring it to a guild meeting or mail it to the workshop coordinator, along with a check made out to Q.U.I.L.T., Inc. for the requested amount (separate check for each workshop).

### Workshop rules:

- Only those who have paid the workshop fee will be allowed into the workshop.
- If you cannot attend the workshop, call the workshop coordinator since there may be a waiting list. If you register for a workshop and do not attend, your registration fee will be forfeited unless another person fills the space.
- Come on time and be well supplied.
- Remember to wear your name tag.
